### <u>Title:</u>

This By-law shall hereby be called the "Fees, Fines and Charges By-law".

### Authority:

WHEREAS The Municipal Act provides under section 231 that a council has the power to pass by-laws to:

(a) Give broad authority to council and to respect its right to govern the municipality in whatever way the council considers appropriate, within the jurisdiction given to it under this and other Acts

**AND WHEREAS** *The Municipal Act* provides under section 232(2) Council may:

(d) establish fees or other charges for services, activities or things provided or done by the municipality or for the use of property under the ownership, direction, management or control of the municipality

(e) subject to the regulations, provide for a system of fees, for inspections, licences, permits or approvals, including any or all of the following:

(i) establishing fees, and terms for payment of fees, for inspections, licences, permits and approvals, including fees related to recovering the costs of regulation,

(ii) establishing fees for licences, permits and approvals that are higher for persons or businesses who do not reside or maintain a place of business in the municipality

**AND WHEREAS** The Municipal By-Law Enforcement Act provides under section 3(2) that:

A Municipality may only require administrative penalties to be paid if it first passes a by-law that does the following:

- (a) Designates the by-law contraventions that may be dealt with by a penalty notice;
- (b) Sets the amount of the administrative penalty for each contravention, which must not exceed the amount prescribed by regulation;
- (c) Sets the period within which a person may pay the administrative penalty or request a review by a screening officer, subject to subsection 10(2)
- (d) Provides for the appointment of one or more screening officers and specifies their powers and duties, which may include:
  - (i) The power to reduce the amount of an administrative penalty set out in a penalty notice, and
  - (ii) The power to enter into a compliance agreement, on behalf of the municipality, with a person to whom a penalty notice has been issued;
- (e) Sets the period within which a person must deal with a screening officer's decision under subsection 11(2);
- (f) Establishes an adjudication scheme described in section 14 to resolve matters relating to administrative penalties and compliance agreements.

NOW THEREFORE the Council of the Rural Municipality of St. Laurent, in a meeting duly assembled, enacts as follows:

- 1. THAT all of the fees, fines and charges to be enforced under this By-law be placed in schedules, attached hereto.
- 2. AND THAT the Rural Municipality of St. Laurent may issue a certificate showing the name of a person required to pay an administrative penalty and the total amount of the administrative penalties due and payable by the person, and may file the certificate in the Court of King's Bench. Once filed, the certificate becomes a judgement of the Court and may be enforced as a judgement.
- **3. AND THAT** for the purposes of enforcing payment of amounts due and payable to the Municipality in relation to designated by-law contraventions, a municipality has the powers and duties of an authority under sections 92 to 94 of *The Provincial Offences Act*. Those sections apply not only to amounts due and payable in relation to contraventions involving the parking of a vehicle, but to amounts due and payable in relation to all designated by-law contraventions for which a penalty notice is issued under *The Municipal By-law Enforcement Act*.
- 4. AND THAT for the purposes of clarity, each schedule shall be updated, when there is a third reading of an amendment to the By-law, to reflect the changes in numbering affected by amendments to those by-laws.
- 5. AND THAT this by-law shall be reviewed no less than once every calendar year, from the date it is passed, and shall be presented on the first scheduled council meeting of each January.

### Coming Into Force

a. THAT this by-law shall come into force on this 6 day of September, 2023.

b. **THAT** when this By-Law shall come into force and take effect as and from the date of the passage thereof, it shall apply to the whole of the Rural Municipality of St. Laurent.

c. **THAT** By-Law No. 8/2022 and any former by-laws dealing with regulating the fees, fines and charges for the Municipality be hereby repealed.

 On a review, a screening officer may make one of the following decisions:

 (a) confirm the administrative penalty;

(b) reduce the amount of the administrative penalty;

(c) enter into a compliance agreement with the person on behalf of the municipality;

(d) cancel the penalty notice if, in the screening officer's opinion,

(i) the contravention did not occur as alleged,

- (ii) the penalty notice does not comply with subsection 6(2) of the MBEA,
- (iii) a ground for cancellation is authorized.

Early payment due is by the 10th day following issuance of infraction notice unless otherwise established in a by-law.

The number of offences is calculated in a calendar year, unless otherwise stated in a by-law
