Leclair – Gaudry

WHEREAS a Subdivision Application under File #4178-22-8191 from Joseph Hueging for property located on SE1-16-3W in the R.M. of St. Laurent has been received for review.

AND WHEREAS the intent of this subdivision is to subdivide a 10-acre property from a 161-acre property (CT2371801, Roll 92200) to allow for the property owner to remain in the residence and sell the agricultural land with the existing second dwelling.

AND FURTHER WHEREAS the Provincial Community and Regional Planning Branch has reported no concerns with this application, subject to the RM being satisfied that the proposed subdivision is in compliance with the intent of the Development Plan policies and completes the following conditions:

1. Written confirmation is submitted by the R.M. that taxes on the land to be subdivided for the current year plus any arrears have been paid or that an arrangement satisfactory to Council has been made.

THEREFORE BE IT RESOLVED THAT Council has no concerns with the application, approves the said subdivision and directs the CAO to complete the above-noted condition(s) and that capital levy fees are waived as no capital improvements are foreseeable with this particular application due to the already existing dwellings on both parcels.
