SUBDIVISIONS CON'T

Res # 258/2023 Johnson - Gaudry

WHEREAS a Subdivision Application under File #4178-23-8253 from 10075927 Manitoba Ltd for property located at Pt. Lot 12 in the Parish of St. Laurent has been received for Council review. AND WHEREAS the intent of this subdivision is to subdivide a 2.01 acre property from an approximately 90.24 acre property (CT 3149327/1, Roll 12900) to create one 2.01 acre property for an existing dwelling. The property is approximately 1 mile south of St. Laurent. The proposed lot contains a dwelling, serviced by a septic field and individual well. There is an existing driveway onto Veteran's Memorial Road.

AND FURTHER WHEREAS the Community Planning Branch has no objections to the subdivision subject to the RM being satisfied that the proposed subdivision is in compliance with the intent of the Development Plan policies.

THEREFORE BE IT RESOLVED THAT Council has no concerns with the application and approves the said subdivision on the following conditions:

- 1. That the land taxes on the land to be subdivided, for the current year plus any arrears, have been paid or that an arrangement satisfactory to Council has been made;
- 2. That a Development Agreement is entered into between the applicant and the RM of St. Laurent to outline the following:
 - a) All structures be built to the Flood Protection Level of 250.64 metres (822.3 fee) CGVD28.; and
 - b) Further development of the residual lot will result in access rationalization. The existing access on the proposed lot would be relocated to the location of a proposed public road. Access to the proposed lot would then come from an internal road network.
